Use of ITRS Codes

Bank officers must be well trained on the use of ITRS codes by the bank management. Regular training should be provided to bank officers to ensure the accuracy of the ITRS code reported to the CBSL.

1. ITRS Code for International Transactions

ITRS code is required for all International 'Credit' and 'Debit' transactions, other than the exceptions of 'International', 'Credit' transactions less than USD 3000 or equivalent credited to personal 'LKR' accounts, 'PFCA' accounts or received from 'Money Transfer (MT) services.

Verifying the ITRS Code

The bank must identify the purpose of the transaction as per Annex 7. If customer is declaring the ITRS Purpose Code, a bank officer must verify the accuracy of the purpose code declared by the customer. In the event the customer cannot be contacted to identify the purpose of the transaction, particularly in credit transactions automatically credited to the customer's account, the bank to declare the purpose code based on available information until the customer can be contacted for verification.

ITRS Code for International Transactions

ITRS code for a 'international' transaction is always a four digit code. The four digits of the ITRS Code for an 'international' transaction is designated in a manner to identify the nature of the transaction by referring to the ITRS code.

The following numbering system is used;

Digit 1: Credit transaction (1) or

Debit transaction (2)

Digit 2: Main category of balance of the type of balance of payment (BOP) transaction, as defined in ITRS

Report 1: Annexure 7: ITRS codes

(ex 1: Trade Transactions

2: Service Account Transactions)

4: Income Account Transactions)

Digit 3 and 4: Sub category under the main category of the BOP transaction

Example 1:

ITRS Code: **1215**Digit 1: 1 (Credit)

Digit 2: 2 (Service Account Transaction)

Digit 3 and 4: 15 (Business Travel)

Example 2:

ITRS Code: **1011**Digit 1: 1 (Credit)

Digit 2: 0 (Financial Account – Real Estate Transaction)

Digit 3 and 4: 11 (Purchase of real estate by non-resident in Sri Lanka)

2. ITRS Codes for Domestic Transactions

Permitted Debit Code / Permitted Withdrawal Code / Permitted Deposit Code

All transactions that are allowed from a specific account type of Domestic Banking Units and Foreign Currency Banking Units have been incorporated under the ITRS Codes for domestic transactions.

Refer ITRS Report 1: Annex 7 for a full list of permitted domestic debit transactions. Permitted domestic transfers to other accounts, domestic withdrawals and domestic deposits are regulated by Directions issued by the Department of Foreign Exchange of the CBSL under the 'Foreign exchange Act No 12 of 2017'.

ITRS Code for 'Domestic' transactions is a five digit code.

Ex – 50201 = 'Transfer to other PFCA – same account holder'

Digit 1 – Refers to Field 7 (Nature of transaction Code)

In this case, 5 = Domestic Debit Transfers (DDT)

(Refer ITRS Report 1: Annex 2)

Digit 2 and 3 – Refers to Account Type Code (refer ITRS Report 1: Annex 4)

In this case, 02 = PFCA Account

Digit 4 and 5 – Unique domestic debit transfer transaction type / Unique domestic deposit type / Unique domestic withdrawal type

(Refer ITRS Report 1: Annex 7)

In this case, 01 = Transfer to Other PFCA – (transferee) same account holder

Accuracy of ITRS codes

The accuracy of the ITRS code is vital to the success of the ITRS system and should be given specific consideration at the time bank officer enters the ITRS purpose code to the system based on information from the customer.

ITRS codes for Foreign Currency Purchases and Foreign Currency Sales

ITRS codes are not required when nature of transaction is either a Foreign currency purchase (Field 7 = 3) OR Foreign currency sale (Field 7 = 4).

Foreign Currency Purchases Or Sales is used ONLY when a specific underlying cross border transaction purpose is not applicable only.

(ex- Tour guide receiving a tip in USD wants to sell USD over the counter. No underline 'International' or 'Domestic' transaction is established in such a scenario)

However, for example, any foreign currency sales by the bank for travel purpose should be considered as 'International Debit' with appropriate 4 digit ITRS code (ex- 2214,2215,2216,2217)
