Workers' Remittances and other transactions through clearing houses

Receipt from clearing house in bulk – reported individually by intermediary bank – to intermediary bank customer

Example 4 – Sampath Bank receives remittances proceeds in bulk from a clearing house in Korea to the LKR vostro account of the clearing house account related to the following 3 transactions.

<u>Note 1</u> - These proceeds are debited from the LKR vostro account of the clearing house and should be reported by the intermediary bank (i.e. Sampath Bank) as the 'bank that makes the final transfer to the customer account'.

Note 2 - The BULK receipt, although an international transaction, should NOT be reported to the ITRS as it will result in a double counting.

Transaction 1 – USD 5,000 to Sampath Bank own LKR customer's account

<u>Note 1</u> – Despite the transaction being a domestic transfer, for these specific types of transactions, it should be reported as an [International Credit (1)] and [ITRS Code] as [Workers' Remittances (1501)]

Note 2 – Since the transaction amount is more than USD 3000, the purpose of the transaction should be verified from the exchange house

Note 1 – Despite the transaction being a domestic withdrawal, for these specific types of transactions, it should be reported as an [International Credit (1)] and [ITRS Code] as [Workers' Remittances (1501)]

<u>Note 2</u> – Since the transaction amount is less than USD 3,000 and as the transaction is over the counter, there is no need to put the ITRS code or the ITRS code can be hard-coded as (1501 = Workers' Remittances)

<u>Note 1</u> – Despite the transaction being a domestic transfer, for these specific types of transactions, it should be reported as an [International Credit (1)] and [ITRS Code] as [Workers' Remittances (1501)]

Note 2 – Since the transaction amount is more than USD 3000, the purpose of the transaction should be verified from the exchange house

Note 3 – [Account Holder Address]: Input beneficiary bank and if available bank branch (ex: HNB-HO)

Note 4 – [Account Type Code]: new account type called [IBT (38)] is introduced

Note 5 – [UIN No], since this is not available with intermediary bank, input the [Account Holder Number]

Note 6 – HNB bank should NOT report the transaction as an inward remittance, to avoid double counting.



- Sampath Bank as the 'bank that makes the final transfer to the customer account' should report ALL transactions SEPERATELY at the point of 'debit' from either the bank 'Suspense Account / General Ledger Account' or at the point of 'debit' from 'Exchange House Vostro Account'.
- Sampath Bank is the originator of the CEFT/SLIPS-clearing code-53 to beneficiaries BOC and HNB
- In such a CEFT/SLIPS-clearing code-53 transaction, beneficiary banks, i.e. HNB and BOC should NOT report, CEFT/SLIPS-clearing code-53 credits coming through a local intermediary bank
- Hence ALL 10 transactions above should be reported separately by Sampath Bank under ITRS Report 1.
 - \circ ~ Sampath Bank must recognise the transaction as 'International Credit'.
 - If an individual transaction amount is less than USD 3000 or equivalent, and the receipt is to an LKR account or PFCA account or and over the counter transaction, ITRS purpose code is NOT necessary
 - o If an individual transaction is to account other than LKR/PFCA or over the counter, the ITRS purpose code is necessary, regardless of the transaction amount
 - If an individual transaction is more than USD 3000 or equivalent, some data for reporting by the 'Intermediary Bank' may not be available with the 'Intermediary Bank'. These data may include the following
 - Field 14: Account Holder Address: INSTRUCTION: Input beneficiary bank and if available bank branch (ex: BOC -HO, HNB-HO or BOC, HNB)
 - Field 15: Account Type Code: INSTRUCTION: A new account type has been introduced to facilitate such transactions. Input IBT: Account Type/Money Transfer Service Types Code Number: 37 (ITRS Report 1: Annexure 4).
 - Bowever, the following data should be requested by the 'Intermediary Bank' from the financial beneficiary bank
 - Ex: Sampath Bank as the 'Intermediary Bank' should request HNB as the bank of the final beneficiary customer should request the following:
 - Field 16: Transactor Sector Code
 - Field 17: UIN Code
 - Field 18: UIN No
 - Field 19: ITRS Code
 - Although the above process may require some time, it is necessary to ensure that the 'Intermediary Bank' reporting adheres to all basic data needs of the ITRS project.

Use of IBT Account Type - i.e. Interbank Transfers for Other Bank's Customer Account

- In some situations, such as explained in Example 19, the **bank that makes the final transfer to the customer account'** will likely not know the customer account type of the customer account held with the other bank.
- In such situations, please use the account type as IBT (ITRS code 37) in [Field 15] as the 'Account Type Code'.

Example 24: Payment in bulk by Citi Bank, New York from its LKR Vostro account to Citi Bank, Colombo LKR Vostro Account maintained in Citi Bank, New York as Pension Fund Payments to USA citizens currently living in Sri Lanka and maintaining accounts in Sampath Bank and HNB, MCB (Citi Bank, Colombo act as an intermediary in the Vostro Transaction through the LKR Vostro account maintained by Citi Bank, Colombo in Citi Bank, New York)

- As in the previous example (Ex 19), Sampath Bank and HNB as the 'banks that makes the final transfer to the customer account' should report ALL transactions SEPERATELY at the point of 'debit'.
- Citi Bank, Colombo should ensure that all individual customer data is available to Sampath Bank and HNB to report the data on an individual basis.
- Sampath Bank and HNB ust identify the purpose of the transaction as an Internationa Credit' and NOT as a domestic transaction.
- If these individual 'credits' are to either LKR or PFCA accounts, ITRS code is necessary only if individual transaction amount is greater than USD 3000 or equivalent.



Debit Card Transactions

Cross Border Debit Card Transactions made by a customer via POS abroad as well as cross border transactions made via internet by a customer from Sri Lanka

- Both above type of transactions should be reported in ITRS Report 5 (Monthly Report) and NOT in ITRS Report 1 (Daily Report).
- This exception is introduced due to the practical difficulty of identifying ITRS Purpose Codes when a customer makes a transaction via a debit card in a foreign POS

Local Debit Card Transactions linked to PFCA /BFCA or any other DBU or OBU account (other than allowed internet based transactions)

- All domestic transactions made via debit cards are considered as 'Domestic Withdrawals' and Reported in ITRS Report 1
- ITRS purpose code should be based on ITRS Codes under 'Domestic Withdrawals'.

Local Debit Card Transactions for internet banking transactions linked to PFCA /BFCA or any other DBU or OBU account

- All domestic debit card transactions made via internet should be reported under 'Domestic Debit Transfers' relevant to the account type under ITRS Report 1
- In most cases, only a limited type of debit transfers are allowed to be conducted via internet from BFCA/BFCA and other foreign currency accounts (mostly limited to transfer to LKR account of same account holder)
- Ex If an internet transaction is done from a PFCA account (ITRS code: 50217 Transfer to LKR account (transferee) same account holder)
- In most cases, only a limited type of debit transfers are allowed to be conducted via internet from BFCA/BFCA and other foreign currency accounts (mostly limited to transfer to LKR account of same account holder)

Travel Card Related Transactions

• All travel card related transactions should be recorded in ITRS Report 1 (Daily Report) as 'International Credit' (ITRS code 1244) or 'International Debit' (ITRS code 2244) transactions and NOT as 'Domestic' transactions.

Example 25: Mr. Bandula Perera, wishes to purchase Rs 100,000 worth of USD notes (USD 500) from the Sampath Bank, BIA airport desk, for the purpose of travel

Note: The 'Nature of the Transaction' should NOT be put as 'Foreign currency Sales' and should be considered as 'International Debit' transaction. For transactions done at the BIA Terminal, a special leeway is given to include the wording 'BIA Terminal' as the 'Çustomer Address' to ensure efficiency of reporting.



Transactions involving the 'General Ledger' or similar bank's own internal account when facilitating cross border and domestic foreign currency transactions

- In some situations, the bank may employ a 'General Ledger' account as an intermediary account to facilitate either cross border transactions or domestic debit transfers of DBU and OBU accounts.
- In such situations, there could also be a time lag in debiting the customer account and actual cross border transaction (Figure 1).
- In such situations, despite the final leg of the transaction initiated trough the intermediary 'General Ledger Account 'or similar account, the data reported should be able to capture the underline customer information, including the customer account number and customer account type.
- In order to facilitate such retrieval of information, linking of the underline transaction data to the 'General Ledger Account' transaction may be necessary.



- As depicted in Figure 1, 'Transaction 1' should be reported as a cross border transaction with a 4 digit ITRS code while 'Transaction 2' should be reported as a 'Domestic debit transfer'.
- For both transactions, the details of the underline Customer Account, Customer Address and other such related information should be 'mapped' to the 'General Ledger Account' transaction.
- Similarly, in Figure 2, customer may directly give instructions and debit directly to the GL account and the GL account is debited to open a FD or to transfer to another account.
- This transaction also should be reported at the time where it is debited from the GL account, however the purpose of the transaction should be established as an 'International Credit' with a 4 digit ITRS purpose code.

Use of 'Foreign Currency Purchases' and 'Foreign Currency Sales'

- Foreign Currency Purchases or Sales is used ONLY when a specific underlying cross border transaction purpose is not applicable only.
- ITRS codes are not required when nature of transaction is either a Foreign currency purchase (Field 7 = 3) OR Foreign currency sale (Field 7 = 4).
- ex- Tour guide receiving a tip in USD wants to sell USD over the counter. No underline 'International' or 'Domestic' transaction is established in such a scenario. (Example 24 above)
- However, for example, any **foreign currency sales by the bank for travel purpose** should be considered as **'International Debit'** with appropriate 4 digit ITRS code (ex- 2214,2215,2216,2217)

Foreign currency sales and purchases at the BIA terminal
