1. Responsibilities

- 1.2 Organizing exhibitions, planning, developing and organizing new collections, maintaining records, dealing with inquiries from public and professionals, conducting research and lectures on findings and on-going activities.
- 1.3 Ensuring that exhibits are properly preserved, preparing literature (leaflets, articles, booklets etc.) to create awareness among public to promote EHM and other museums.
- 1.4 Attending to other responsibilities assigned by CBSL with regard to the currency museum from time to time.

 - A Degree, preferably in Archeology or History from a local or foreign University, recognized by the University Grants Commission of Sri Lanka with one of the following;
 - a. Diploma or higher qualification in curating from a recognized institution.
 - b. Minimum of two years' experience in museum curating.
- 2.3 Age Limit: Not below 18 years and not above 40 years as at 26.10.2018.
- **3. Remuneration:** An attractive salary and special payment of two months gross salary per annum, Provident Fund & Employees' Trust Fund, medical scheme, staff loan facilities.
