A firm may submit bids as a single Bidder on its own, when submitting bids in response to this tender.

If a Bidder intends to subcontract major items of supply or services, it shall include in the bid details of the name and nationality of the proposed Subcontractor, including vendors, for each of those items. Bidders are free to list more than one Subcontractor against each item. Quoted rates and prices will be deemed to apply, whichever Subcontractor is appointed, and no adjustment of the rates or prices will be permitted. Any subsequent additions or deletions of Subcontractors shall be done only with the prior approval of the EPF Department of CBSL.

For the purposes of these Bidding Documents, a Subcontractor is any vendor or service provider with whom the Bidder contracts for the supply or execution of any part of the System to be provided by the Bidder under the Contract (such as the supply of major hardware, software, or other components of the required Information Technologies specified, or the performance of related Services, e.g., software development, transportation, installation, customization, integration, commissioning, training, technical support, maintenance, repair, etc.).

For the purposes of establishing a Bidder's qualifications, the experience and / or resources of any Subcontractor will not contribute to the Bidder's qualifications; only those of a Bidder's will be considered.

The Bidder shall be eligible for the quoted brand of equipment (servers, SAN Storage, SAN switches, ethernet switches ... etc) separately.
