TENDER FOR THE SUPPLY, DELIVERY AND COMMISSIONING OF 2 NOS. OF HANDHELD EXPLOSIVE TRACE DETECTORS FOR THE CENTRAL BANK OF SRI LANKA

Sealed quotations are invited for the Supply, Delivery and Commissioning of 02 Nos. of Handheld Explosive Trace Detectors for the Central Bank of Sri Lanka (CBSL) as follows.

1. Eligibility Criteria:

- 1.1. Tenderer must have at least one (01) project of supplying/maintaining of security screening devices in Sri Lanka during past 5 years ended from 30th November 2021 amounting to Rs. 2 million or above (Annex I - a).
- 1.2. Tenderer shall be an authorized agent for the quoted brand of Explosive Trace Detectors in Sri Lanka (Tenderer shall provide documentary evidence in this regard -Annex I - b).
- 1.3. Tenderer must have at least one (01) certified technician and the relevant certification should be provided with the tender document.

2. Technical Specifications:

Required minimum technical specifications are in Annex II.

3. Price Schedule:

The tenderers shall quote prices as per the Annex III – Price Schedule. The price quoted inclusive of all local taxes should be in Sri Lanka Rupee (Rs.) and valid until 19/06/2022. The price shall remain unchanged during the validity period of the tender.

4. Submission of financial proposals for different models

Tenderers may submit bids for different models. For each model, tenderer shall submit separate price schedules and forms of tender.

5. Bid Guarantee:

The tenderer should furnish a Bid Guarantee amounting to a sum of Rs. 80,000.00 valid until 19/07/2022 by way of a Bank Guarantee substantially in the form of Annex VII or a Bank Draft in favor of the Monetary Board of the Central Bank of Sri Lanka, obtained from a Licensed Commercial Bank operating in Sri Lanka. The Bid Guarantee shall be available at the time of the tender opening.

6. Performance Guarantee:

Within 14 days from the date of letter of award of the contract by the CBSL, the successful tenderer shall furnish a Performance Guarantee substantially in the form of Annex VIII in a sum equivalent to 10% of the total Contract Price for the due performance of the contract which should be valid for 150 days from the date of letter of award. Such Performance Guarantee shall be in the form of a Bank Guarantee issued in favor of the Monetary Board of the Central Bank of Sri Lanka obtained from a licensed commercial bank operating in Sri Lanka and forwarded to the Secretary of the CBSL.

A successful tenderer who fails to furnish the required Performance Guarantee as specified above shall be deemed to be disinterested in accepting the award, and the Bid Guarantee shall be forfeited.

7. Pre-bid Meeting:

8. Delivery Period and Liquidated Damages:

The successful tenderer shall supply required items within 120 days from the date of the letter of award. Failure to deliver the required items within this period would render the supplier liable to pay liquidated damages at the rate of Rs. 10,000.00 per each day and up to maximum of 10% of the total contract value of delay and such amounts will be deducted from the payment due to the supplier.

9. Maintenance Services:

The successful tenderer shall provide maintenance services for the equipment and provide spare parts at no additional cost to the CBSL during the comprehensive warranty period.

10. Supplying of Spares:

Tenderer shall supply only genuine spare parts and consumable items during the warranty period and post warranty period. All spare parts and consumable items which will be found not genuine during the pre-acceptance inspection at the CBSL will be rejected and the successful bidder is required to replace such spare parts and consumable items with genuine spare parts and consumable items free of charge within two weeks of such notification to the CBSL. In addition to above, repetition of delivery of non-genuine spare parts and consumable items may result in initiating action for forfeiting the guarantee/cancellation of registration/classification of such bidder as a defaulted supplier.

11. After Sales service requirements:

The Bidders should have 24x7 call center support. The bidder should provide support and maintenance services for the tendered items 24x7 basis with on-site (Central Bank of Sri Lanka, No. 30, Janadhipathi Mawatha, Colombo 01.) support whenever requested by the CBSL.

12. Payment Method:

All payments will be subject to existing taxes as applicable in terms of the Inland Revenue Act No. 24 of 2017 and any subsequent amendments and notices issued by the Department of Inland Revenue, Sri Lanka. The conditions of the payments are as follows.

- i. 20% of the contract sum will be paid as an Advance Payment on receipt of an on-demand guarantee from a licensed commercial bank operating in Sri Lanka valid for 120 calendar days.
- ii. An amount equivalent to 70% of the contract sum will be paid after 14 days from the date of supply, delivery and commissioning to the CBSL and the retention 10% will be paid after 90 days from the previous payment (70% of the contract sum) subject to the satisfactory performance of tendered items/services.
- iii. All the above payments will be made on the recommendation of the Director, Security Services Department, CBSL.
- iv. The successful tenderer shall submit a copy of VAT Registration Certificate (if any).

Financial Evaluation

Financials will be evaluated considering the USD Telegraphic Transfer Selling rate published by the CBSL at the date of closing the bids using the unit prices provided in USD by the tenderers in the Price Schedule (Annex III) for the items 1, 2 and 3 (Total price for goods). Total evaluated price will be the total of 'Total price for goods' and 'Local Handling Charges'.

Payment

The selected supplier is required to provide the proof documents of the transaction between the respective bank and the supplier in order for the CBSL to release the payment based on the actual exchange rate provided by the bank for the items 1, 2 and 3 in the price schedule. All other bank charges shall be borne by the supplier. Further, the total payment is subject to Clause 12 Payment Method of this tender.

15. Selection Method:

- i. The evaluation will be based on the cost and quality method subject to substantial compliance with Tender conditions.
- ii. The CBSL reserves to itself the right to accept any or reject any or all tender(s) or any part of the tender received and is not bound to accept the lowest quotation. The decision of the CBSL shall be final with regard to the award of the contract.

Protecting against explosive-based terrorism can thus only be accomplished by deploying explosive trace detection in critical infrastructure. Hence, proposed system should be designed for mobile applications with lightweight and ergonomic suitability for extended handheld use. System **SHOULD NOT HAVE A RADIOACTIVE SOURCE** used for identification/verification.
