**ISSUE OF RS 30,000 MILLION TREASURY BONDS**

Rs. 10,000 million Treasury Bonds under the existing series of 10.60% 2019‘B’ and Rs. 20,000 million Treasury Bonds under the existing series of 11.20% 2023‘A’ are to be re-opened for the auction on March 26, 2015.
