ISSUE OF RS 25,000 MILLION TREASURY BONDS

Rs. 5,000 million Treasury Bonds under the existing series of 08.00% 2020 'A' and Rs. 20,000 million Treasury Bonds under the existing series of 10.25% 2025 'A' are to be re-opened for the auction on March 30, 2015.
