ISSUE OF RS 6,000 MILLION TREASURY BONDS

Rs.3,000 million Treasury Bonds under the existing series of 08.50% 2018‘D’ and Rs. 3,000 million Treasury Bonds under the existing series of 11.20% 2022‘A’ are to be re-opened for the auction on April 21, 2015.
