ISSUE OF RS 10,000 MILLION TREASURY BONDS

Rs.5,000 million Treasury Bonds under the existing series of 08.50% 2018‘A’ and Rs. 5,000 million Treasury Bonds under a new series of 09.25% 2020‘A’ are to be opened for the auction on 5th May, 2015.
