ISSUE OF RS 20,000 MILLION TREASURY BONDS

Rs. 3,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs. 7,000 million Treasury Bonds under the series of 11.20% 2023 'A' and Rs. 10,000 million Treasury Bonds under the series of 11.00% 2030 'A' are to be issued through an auction on May 28, 2015.
