ISSUE OF RS 12,000 MILLION TREASURY BONDS

Rs. 2,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs. 3,000 million Treasury Bonds under the series of 10.00% 2022 'A' and Rs. 7,000 million Treasury Bonds under the series of 10.25% 2025 'A' are to be issued through an auction on June 12, 2015.
