

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 40,000 MILLION TREASURY BONDS

Rs. 15,000 million Treasury Bonds under the series of 9.25% 2020'A', Rs. 10,000 million Treasury Bonds under the series of 9.45% 2021'A' and Rs. 15,000 million Treasury Bonds under the series of 10.00% 2022'A' are to be issued through an auction on July 09, 2015.
