

DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 20,000 MILLION TREASURY BONDS

Rs. 10,000 million Treasury Bonds under the series of 8.75% 2018'A' and Rs. 10,000 million Treasury Bonds under the series of 11.20% 2023'A' are to be issued through an auction on July 14, 2015.
