

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 8,000 MILLION TREASURY BONDS

Rs. 3,000 million Treasury Bonds under the series of 9.25% 2020'A' and Rs. 5,000 million Treasury Bonds under the series of 11.00% 2025'A' are to be issued through an auction on August 11, 2015.
