ISSUE OF RS 40,000 MILLION TREASURY BONDS

Rs. 5,000 million Treasury Bonds under the series of 8.00% 2019 'A', Rs. 10,000 million Treasury Bonds under the series of 11.20% 2023 'A', Rs. 12,500 million Treasury Bonds under the series of 11.00% 2025 'A' and Rs. 12,500 million Treasury Bonds under the series of 11.00% 2030 'A' are to be issued through an auction on August 25, 2015.
