**ISSUE OF RS 16,000 MILLION TREASURY BONDS**

Rs. 3,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs. 5,000 million Treasury Bonds under the series of 10.00% 2022 'A', Rs. 5,000 million Treasury Bonds under the series of 11.00% 2025 'A' and Rs. 3,000 million Treasury Bonds under the series of 11.50% 2028 'A' are to be issued through an auction on September 15, 2015.
