ISSUE OF RS 12,000 MILLION TREASURY BONDS

Rs. 2,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs. 3,000 million Treasury Bonds under the series of 11.00% 2026 'A' and Rs. 7,000 million Treasury Bonds under the series of 11.50% 2035 'A' are to be issued through an auction on November 27, 2015.
