

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 10,000 MILLION TREASURY BONDS

Rs. 2,000 million Treasury Bonds under the series of 9.50% 2020 'A', Rs. 3,000 million Treasury Bonds under the series of 11.20% 2023 'A' and Rs. 5,000 million Treasury Bonds under the series of 11.00% 2025 'A' are to be issued through an auction on December 23, 2015.
