

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 13,000 MILLION TREASURY BONDS

Rs. 3,000 million Treasury Bonds under the series of 8.00% 2019 'A', Rs. 5,000 million Treasury Bonds under the series of 9.45% 2021 'A' and Rs. 5,000 million Treasury Bonds under the series of 11.50% 2028 'A' are to be issued through an auction on December 29, 2015.
