

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 6,000 MILLION TREASURY BONDS

Rs. 2,000 million Treasury Bonds under the series of 8.00% 2019 'A', Rs. 2,000 million Treasury Bonds under the series of 11.00% 2021 'A' and Rs. 2,000 million Treasury Bonds under the series of 11.40% 2024 'A' are to be issued through an auction on March 10, 2016.
