ISSUE OF RS 20,000 MILLION TREASURY BONDS

Rs. 5,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs.5,000 million Treasury Bonds under the series of 9.45% 2021 'A', Rs. 5,000 million Treasury Bonds under the series of 10.00% 2022 'A' and Rs. 5,000 million Treasury Bonds under the series of 10.25% 2025 'A' are to be issued through an auction on March 24, 2016.
