

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 40,000 MILLION TREASURY BONDS

Rs. 10,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs.10,000 million Treasury Bonds under the series of 10.25% 2025 'A', Rs. 10,000 million Treasury Bonds under the series of 11.00% 2026 'A' and Rs. 10,000 million Treasury Bonds under the series of 11.00% 2030 'A' are to be issued through an auction on March 29, 2016.
