**ISSUE OF RS 25,000 MILLION TREASURY BONDS**

Rs. 5,000 million Treasury Bonds under the series of 8.50% 2018 'A', Rs.5,000 million Treasury Bonds under the series of 10.60% 2019 'A', Rs. 5,000 million Treasury Bonds under the series of 11.00% 2021 'A' and Rs. 10,000 million Treasury Bonds under the series of 11.50% 2028 'A' are to be issued through an auction on March 31, 2016.
