

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 15,000 MILLION TREASURY BONDS

Rs. 5,000 million Treasury Bonds under the series of 9.50% 2020 'A', Rs.5, 000 million Treasury Bonds under the series of 10.00% 2022 'A' and Rs. 5,000 million Treasury Bonds under the series of 11.40% 2024 'A' are to be issued through an auction on April 18, 2016.
