

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 19,000 MILLION TREASURY BONDS

Rs. 5,000 million Treasury Bonds under the series of 8.00% 2018 'A', Rs.5,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs. 5,000 million Treasury Bonds under the series of 10.00% 2022 'A' and Rs. 4,000 million Treasury Bonds under the series of 11.40% 2024 'A' are to be issued through an auction on May 12, 2016.
