

DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 45,000 MILLION TREASURY BONDS

Rs. 10,000 million Treasury Bonds under the series of 8.00% 2018 'A', Rs.10,000 million Treasury Bonds under the series of 9.25% 2020 'A', Rs. 12,500 million Treasury Bonds under the series of 11.40% 2024 'A' and Rs. 12,500 million Treasury Bonds under the series of 11.00% 2026 'A' are to be issued through an auction on May 19, 2016.
