**ISSUE OF RS 45,000 MILLION TREASURY BONDS**

Rs. 10,000 million Treasury Bonds under the series of 8.75% 2018 'A', Rs.15,000 million Treasury Bonds under the series of 9.45% 2021 'A', Rs. 12,000 million Treasury Bonds under the series of 11.40% 2024 'A' and Rs. 8,000 million Treasury Bonds under the series of 11.00% 2026 'A' are to be issued through an auction on May 26, 2016.
