

DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 30,000 MILLION TREASURY BONDS

Rs. 7,000 million Treasury Bonds under the series of 8.50% 2019 'A', Rs.10,000 million Treasury Bonds under the series of 9.50% 2020 'A', Rs. 7,000 million Treasury Bonds under the series of 10.00% 2022 'A' and Rs. 6,000 million Treasury Bonds under the series of 10.25% 2025 'A' are to be issued through an auction on June 27, 2016.
