ISSUE OF RS 34,000 MILLION TREASURY BONDS

Rs. 12,000 million Treasury Bonds under the series of 8.50% 2019 'A', Rs.12,000 million Treasury Bonds under the series of 10.75% 2021 'A', Rs. 10,000 million and Treasury Bonds under the series of 11.00% 2025 'A' are to be issued through an auction on June 30, 2016.
