ISSUE OF RS 35,000 MILLION TREASURY BONDS

Rs. 10,000 million Treasury Bonds under the series of 10.60% 2019 'B', Rs.9,000 million Treasury Bonds under the series of 10.75% 2021 'A', Rs. 9,000 million Treasury Bonds under the series of 10.00% 2022 'A' and Rs. 7,000 million Treasury Bonds under the series of 11.20% 2023 'A' are to be issued through an auction on July 08, 2016.
