**ISSUE OF RS 23,000 MILLION TREASURY BONDS**

Rs. 9,000 million Treasury Bonds under the series of 8.75% 2018 'A', Rs.8,000 million Treasury Bonds under the series of 10.75% 2021 'A', Rs. 6,000 million and Treasury Bonds under the series of 11.00% 2025 'A' are to be issued through an auction on July 14, 2016.
