

DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 60,000 MILLION TREASURY BONDS

Rs. 20,000 million Treasury Bonds under the series of 10.75% 2021 'A', Rs.20,000 million Treasury Bonds under the series of 11.00% 2024 'A', Rs. 20,000 million and Treasury Bonds under the series of 11.50% 2026 'A' are to be issued through an auction on July 29, 2016.
