ISSUE OF RS 33,000 MILLION TREASURY BONDS

Rs. 6,000 million Treasury Bonds under the series of 10.75% 2019 'A', Rs.13,500 million Treasury Bonds under the series of 11.50% 2021 'A' and Rs. 13,500 million Treasury Bonds under the series of 11.00% 2024 'A' are to be issued through an auction on January 27, 2017.
