

## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 66,000 MILLION TREASURY BONDS

Rs. 9,000 million Treasury Bonds under the series of 10.75% 2019 'A', Rs.19,000 million Treasury Bonds under the series of 11.50% 2021 'A', Rs. 19,000 million Treasury Bonds under the series of 11.00% 2024 'A' and Rs. 19,000 million Treasury Bonds under the series of 11.50% 2026 'A' are to be issued through an auction on February 23, 2017.
