**ISSUE OF RS 20,000 MILLION TREASURY BONDS**

Rs. 12,500 million Treasury Bonds under the series of 10.75% 2019 'A' and Rs. 7,500 million Treasury Bonds under the series of 11.00% 2024 'A' are to be issued through an auction on March 13, 2017.
