**ISSUE OF RS 45,000 MILLION TREASURY BONDS**

Rs. 9,000 million Treasury Bonds under the series of 11.00% 2021 'A', Rs. 18,000 million Treasury Bonds under the series of 11.50% 2023 'A', Rs. 9,000 million Treasury Bonds under the series of 10.25% 2025 'A' and Rs. 9,000 million Treasury Bonds under the series of 11.75% 2027 'A' are to be issued through an auction on June 13, 2017.
