

DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ISSUE OF RS 65,000 MILLION TREASURY BONDS

Rs. 16,000 million Treasury Bonds under the series of 11.50% 2021 'A', Rs. 19,000 million Treasury Bonds under the series of 11.50% 2023 'A', Rs. 15,000 million Treasury Bonds under the series of 10.25% 2025 'A' and Rs. 15,000 million Treasury Bonds under the series of 11.75% 2027 'A' are to be issued through an auction on July 11, 2017.
