# CONDITIONS

- 1. Suppliers/authorized dealers and manufacturers/contractors who are already registered with the Bank shall re-apply for the registration for the year 2020.
- 2. Contractors who are registered with CIDA (indicate the category) or ACCSL will only be eligible to register for works on construction.
- 3. Air Line Ticketing agents who are registered with the Civil Aviation Authority, Sri Lanka will only be eligible to register for airline ticketing services.
- 4. Registered firms with the Provincial Council/Divisional Secretariat and approved by the Ministry of Defence for providing Security Services are only eligible to register for supply of Security Personnel.
- 5. Copies of the necessary documents to prove that the applicants fulfill the condition no.2 and 3, should be submitted along with the duly filled application forms.
- 6. Application should be made on the prescribed set of forms obtainable by submission of a written request on a business letterhead at the Mail Room, Level 4(Ground Floor), Central Bank Head Office Building, Colombo 1 on payment of a non-refundable fee of Rs.500/- in cash per set of forms for each group of items. Application forms can be examined free of charge.
- 7. Acceptance of cash and issue of set of application forms: Between 9.00 a.m and 3.00 p.m on working days of the bank up to 08.11.2019 and acceptance of duly completed application forms ends on 15.11.2019.
- 8. Applicants, who wish to register for more than one group, should send separate application forms for each group, which should be enclosed in one cover.
- 9. All applications should be clearly marked "REGISTRATION OF SUPPLIERS, AUTHORIZED DEALERS AND CONTRACTORS FOR THE YEAR 2020" on the top left hand corner of the envelope should be sent by registered post to Secretary, Secretariat Department, 11th Floor, Central Bank of Sri Lanka, No.30, Janadhipathi Mawatha, Colombo 01.
- 10. Quotations will normally be called from the registered suppliers/authorized dealers and manufacturers/contractors. The Bank, however, reserves itself the right to (a) invite quotations from non-registered authorized dealers/suppliers and manufacturers/contractors and (b) to reject any application received for registration whose credentials upon evaluation are found to be unsatisfactory.
- 11. Names of those who fail to quote promptly when required or fail to deliver/provide services on time and in conformity with the specifications, samples or as prescribed in the purchase order and who supply substandard goods are liable to be expunged from the register.
