TERMS AND CONDITIONS FOR REGISTRATION

Transportation Services

- (i) Quotations will generally be called from the registered suppliers/ authorized dealers and manufacturers/ contractors. The CBSL, however, reserves itself the right to invite quotations from non-registered authorized dealers/ suppliers and manufacturers/ contractors.
- (ii) The CBSL reserves itself the right to reject any application received for registration whose credentials upon evaluation are found to be unsatisfactory.
- (iii) Suppliers, authorized dealers, manufacturers and contractors who are already registered with the Bank for year 2020 shall re-apply for the registration for the year 2021.
- (iv) Only the contractors who are registered with Construction Industry Development Authority (CIDA) or National Construction Association of Sri Lanka (NCASL) will be eligible to get registered for constructions.
- Only the airline ticketing agents who are registered with the Civil Aviation Authority/Sri Lanka will be eligible to get registered for airline ticketing services.
- (vi) Only the firms registered with the Provincial Council/Divisional Secretariat and approved by the Ministry of Defense for providing Security Services will be eligible to get registered for the supply of Security Personnel. (vii) Copies of the necessary documents to prove that the applicants fulfill the conditions required under (iv), (v) and
- (vi) above should be submitted along with the duly filled application forms.
- (viii) All the applications which do not contain the necessary supporting documents and reach after the deadline will be rejected. (ix) Names of those who fail to quote promptly when required or fail to deliver goods and services on time or who
- supply substandard goods, services, repairs and maintenance will be expunged from the register.

SUBMISSION OF APPLICATIONS

- Applications will not be issued from the CBSL Head Office premises due to the current health and safety measures carried out by the Government.
