ISSUE OF RS 100,000 MILLION TREASURY BONDS

Rs. 25,000 million Treasury Bonds under the series of 10.75%2028 'A', Rs. 30,000 million Treasury Bonds under the series of 11.00%2030 'A' and Rs. 45,000 million Treasury Bonds under the series of 09.00%2032 'A' are to be issued through an auction on April 29, 2024.
