**ISSUE OF RS 60,000 MILLION TREASURY BONDS**

Rs. 45,000 million Treasury Bonds under the series of 11.75%2029 'A' and Rs. 15,000 million Treasury Bonds under the series of 09.00%2032 'A' are to be issued through an auction on August 13, 2024.
