(a) Nation Lanka Finance PLC has continuously been violating/contravening provisions of the Finance Business Act, No.42 of 2011. Therefore, mobilising public funds including new deposits in whatsoever manner is prohibited. Further, resolution actions have been initiated under the provisions of the Banking (Special Provisions) Act, No. 17 of 2023 with effect from 04.07.2025 and an administrator has been appointed to the Company.

Important to Remember

- The Central Bank of Sri Lanka regulates and supervises the above mentioned licensed commercial banks, licensed specialised banks and finance companies in terms of the relevant legal and regulatory framework, in order to promote safety and soundness of the overall banking sector and finance companies sector.
- The Central Bank of Sri Lanka does not have a legal authority to guarantee deposits of licensed commercial banks, licensed specialised banks and finance companies. However, licensed commercial banks, licensed specialised banks and finance companies are required to insure their deposit liabilities, subject to few exceptions, under the Sri Lanka Deposit Insurance Scheme (SLDIS) established by the Central Bank of Sri Lanka. Currently, the maximum payable compensation under this scheme is Rs. 1,100,000 per depositor, per institution, in the event the licence issued to a member institution is cancelled by the Central Bank of Sri Lanka.
- Public is advised to exercise due care to ensure the safety of their funds and refrain from depositing funds in unauthorised institutions.
