Estimates for the period 1950 - 1958 have been computed using the growth rates in "Estimates of Sri Lanka's Gross National Product from 1950 - 1981", T. Savundranayagam, Staff Studies Vol. 12 No.2, September, 1982 and Vol. 13 No.1 and 2, April - September, 1983. Therefore, from 1950-1958 the sectoral shares do not add to 100%. National Accounts estimates were revised in 1970, 1982, and 1996. The estimates of the latter series are given in this table. The GNP and GDP estimates before the revision are given below:

- (a) This is the rate at which the Central Bank grants advances to commercial banks to meet temporary liquidity requirements. After August 1977, each bank, depending on its holdings of selected asset items, was allocated a certain quota of the total borrowings permitted at the Bank Rate. Borrowings in excess of this quota were subjected to a penal interest rate of 15 per cent per annum. In September 1979, a graduated scale of penal rates ranging from 15.00 per cent to 25.00 per cent was introduced. It was further revised upward to a range of 20 per cent to 30 per cent, with effect from April 1980. With effect from August 1980, the Bank Rate was raised to 14 per cent, while the penal rates were raised to a range of 21 per cent to 30 per cent. With effect from November 1983, the Bank Rate was brought down to 13 per cent and the penal rate was fixed at 20 per cent. With effect from 23 November 1983, the practice of granting advances to commercial banks under the penal rate was discontinued. With effect from 30 December 1985, the Central Bank reduced the lending rates on its advances to 11 per cent. A further reduction, to 10 per cent, was made with effect from 7 August 1987. The Central Bank increased the lending rate on advances to 14 per cent with effect from 15 June 1989. The rate was increased again to 15 per cent, with effect from 6 July 1990 and to 17 per cent with effect from 4 January 1991. The Bank Rate was reduced to 16 per cent on 13 August 1999. It was then raised to 18 per cent, 20 per cent and 25 per cent, on 02 October 2000, 08 November 2000 and 21 November 2000, respectively. The rate was reduced again to 23 per cent with effect from 02 July 2001, 18 per cent with effect from 27 December 2001 and to 15 per cent with effect from 15 August 2003.
