

Weekly Economic Indicators

09th April 2020





Highlights of the Week



During the period under review (04.04.2020 to 09.04.2020), crude oil prices increased to some extent. Oil prices increased amid attempts of major oil producers to curtail further fall in global oil prices. Overall, Brent prices increased by US\$ 1.09 per barrel and WTI prices marginally decreased by US\$ 0.33 per barrel during the period.



Monetary Sector

Weekly AWPR for the week ending 09th April 2020 increased by 18 bps to 9.42 per cent compared to the previous week.

The reserve money increased compared to the previous week mainly due to the increase in currency in circulation.

The total outstanding market liquidity was a surplus of Rs. 21.435 bn by end of the week, compared to a surplus of Rs. 69.139 bn by the end of last week.



External Sector

During the year up to 09th April 2020 the Sri Lankan rupee depreciated against the US dollar (9.1 per cent). Given the cross currency exchange rate movements, the Sri Lankan rupee depreciated against the pound sterling (3.7 per cent), the Indian rupee (3.2 per cent), the euro (6.1 per cent) and the Japanese yen (8.8 per cent) during this period.

The gross official reserves were estimated at US dollars 7,525.7 million as at 31st March 2020.
