
Weekly Economic Indicators

13th May 2021





Highlights of the Week

Real Sector

During the first quarter of 2021, domestic tea production increased in comparison to the corresponding period of the previous year owing to favourable weather conditions and prices. Production of rubber also increased in response to high market prices while coconut production increased considerably due to the lagged effect of favourable weather conditions prevailed during latter part of 2020.

During the period under review (08.05.2021 to 13.05.2021), crude oil prices showed a mixed performance. At the beginning of the week, prices declined on concerns of a weaker demand outlook from Asia due to the rising COVID-19 cases in India. However, prices increased thereafter, owing to industry data that showed a drop in US crude inventories as a result of the shutdown of the biggest fuel pipeline in the US due to a cyber attack. Overall, Brent and WTI prices increased by US dollars 0.02 per barrel and US dollars 0.25 per barrel, respectively, during the period.

Monetary Sector

Weekly AWPR for the week ending 13th May 2021 decreased by 2 bps to 5.72 per cent compared to the previous week.

The reserve money increased compared to the previous week mainly due to the increase in currency in circulation and deposits held by the commercial banks with the Central Bank.

The total outstanding market liquidity was a surplus of Rs. 130.563 bn by the end of this week, compared to a surplus of Rs. 135.173 bn by the end of last week.

By 13th May 2021, the All Share Price Index (ASPI) decreased by 0.19 per cent to 7,228.23 points and the S&P SL 20 Index decreased by 0.21 per cent to 2,869.52 points, compared to the index values of last week.

External Sector

During the year up to 13th May 2021 the Sri Lankan rupee depreciated against the US dollar (6.6 per cent). Given the cross currency exchange rate movements, the Sri Lankan rupee depreciated against the pound sterling (9.4 per cent), the Indian rupee (6.0 per cent), the Euro (4.8 per cent) and the Japanese yen (0.7 per cent) during this period.




