# Highlights of the Week

## Real Sector

At the beginning of the period between 22 to 26 September 2025, crude oil prices declined mainly owing to concerns of an oversupply. Prices picked up later supported by delayed restart of Iraqi-Kurdish exports, surprise drop in US crude oil inventories and export issues in Iraq, Venezuela and Russia. Overall, Brent and WTI crude oil price increased by US dollars 2.61 per barrel and US dollars 2.29 per barrel, respectively, during the period under review.

## Monetary Sector

Weekly Average Weighted Prime Lending Rate (AWPR) for the week ending 26 September 2025 decreased by 02 bps to 8.05 per cent compared to the previous week.

The Average Weighted Call Money Rate (AWCMR) remained unchanged at 7.86 per cent on 26 September 2025 compared to the end of last week.

The reserve money increased compared to the previous week mainly due to the increase in deposits held by the commercial banks with the Central Bank.

The total outstanding market liquidity was a surplus of Rs. 150.03 bn by 26 September 2025, compared to a surplus of Rs. 126.81 bn by the end of last week.

By 26 September 2025, the All Share Price Index (ASPI) increased by 2.44 per cent to 21,598.99 points and the S&P SL 20 Index increased by 1.92 per cent to 6,111.57 points, compared to the index values of last week.

## Fiscal Sector

During the eight months ending August 2025, government revenue and grants increased to Rs. 3,301.5 bn compared to Rs. 2,565.9 bn in the corresponding period of 2024.

Total expenditure and net lending increased to Rs. 3,712.5 bn during the eight months ending August 2025 compared to Rs. 3,476.9 bn in the corresponding period of 2024.

During the eight months ending August 2025, overall budget deficit decreased to Rs. 411.0 bn compared to Rs. 911.0 bn recorded in the corresponding period of 2024.

During the eight months ending August 2025, net domestic financing decreased to Rs. 462.9 bn compared to Rs. 742.4 bn in the corresponding period of 2024. Foreign financing recorded a net repayment of Rs. 51.8 bn during the eight months ending August 2025 compared to the net foreign financing of Rs. 168.6 bn recorded in corresponding period of 2024.

Outstanding central government debt increased to Rs. 29,634.8 bn by end June of 2025 from Rs. 28,738.7 bn as at end 2024. By the end of June 2025, total outstanding domestic debt amounted to Rs. 18,806.1 bn while the rupee value of total outstanding foreign debt amounted to Rs. 10,828.7 bn.

During the week, T-Bill and T-Bond yield rates remained broadly stable.

The rupee value of T-Bills and T-Bonds held by foreign investors remained broadly stable compared to the previous week.

In the reporting week, the auction for T-Bills experienced an oversubscription rate of approximately 1.8 times.

The total volume of secondary market transactions in T-Bills and T-Bonds decreased by approximately 1.4 per cent in the reporting week compared to the week before.

## External Sector

Year to date depreciation of Sri Lanka rupee against the US dollar was 3.3 per cent as of 26 September 2025.

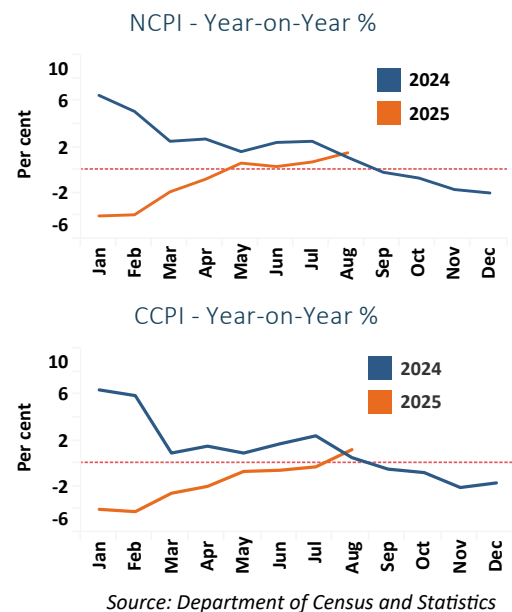

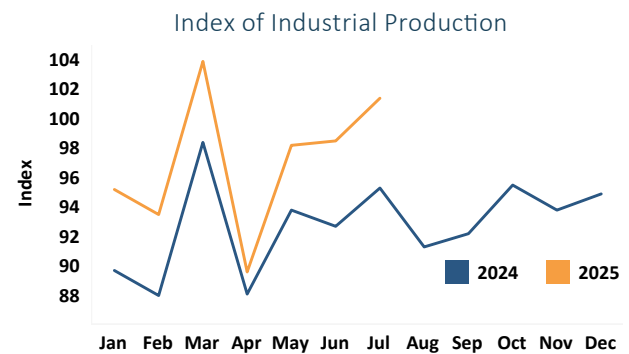

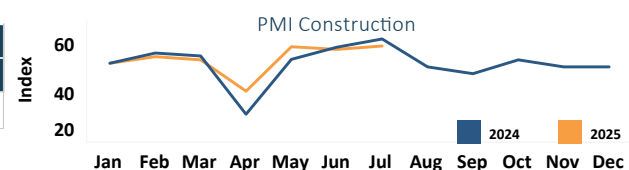

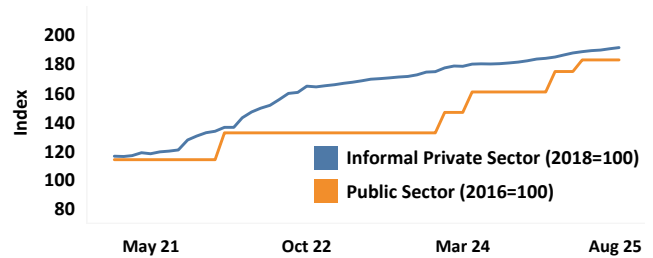

Nominal Wage Rate Indices



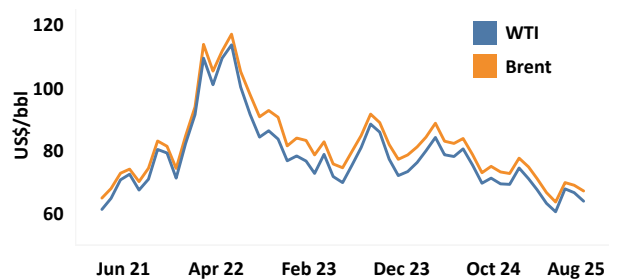

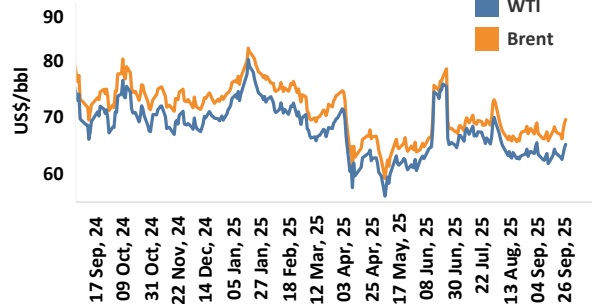

Crude Oil Prices - Daily

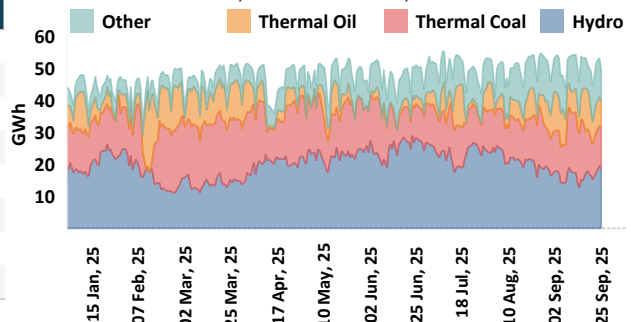

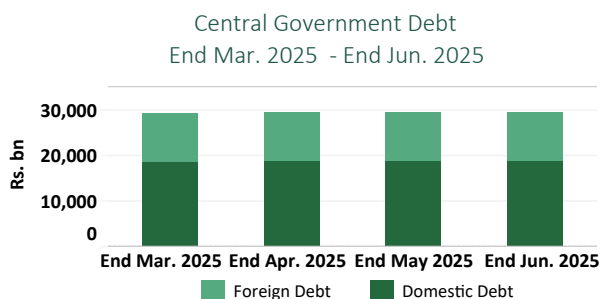

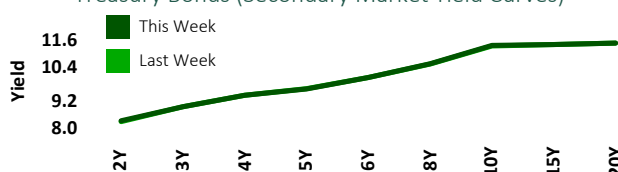
