REPLACEMENT OF 3 NOS. PASSENGER ELEVATORS AT THE CENTRAL BANK OF SRI LANKA

1. The Director of Facilities Management Department, Central Bank of Sri Lanka (CBSL) invites sealed tenders for the Replacement of 03 Nos. Passenger Elevators at CBSL. Receiving of Tenders will be closed at **1430 hrs. on 28th June 2019**.
2. The works consist of replacement of the existing passenger elevators at Centre for Banking Studies and Sovereign Residencies, Rajagiriya, and Regional Office, Anuradhapura.
3. In order to be eligible to bid, the bidder shall be a firm/company registered in Sri Lanka having experience in supply, installation, and maintenance of passenger elevators during the past ten (10) years and shall have completed at least three (03) passenger elevator installations during the past five (05) years where the contract value exceeds Rs. 10 million in each case.
4. Bidding Documents will be issued free of charge at the Mail Room, Central Bank Head Office Building, No 30, Janadhipathi Mawatha, Colombo 1 from **0900 hrs. up to 1600 hrs. from 3rd June 2019 to 21st June 2019** during Bank working days upon receipt of a written request on a business letterhead.
5. The time period for completion of whole of the works shall be 225 days.
6. Bid shall be accompanied by a Bid Security of Rs. 150,000.00 valid for 90 calendar days obtained from a licensed commercial bank operating in Sri Lanka.
7. Duly filled bids secured in a sealed envelope should be sent by registered post to reach the Director of Facilities Management, Central Bank of Sri Lanka, No.30 Janadhipathi Mawatha, Colombo 1 or be lodged in the Tender Box placed at the Mail Room, Ground Floor, Central Bank Head Office Building by **1430 hrs. on 28th June 2019**. 'Tender for Replacement of 3 Nos. Passenger Elevators at the Central Bank of Sri Lanka' should be clearly labeled on the envelope.
8. Bids will be closed at **1430 hrs. on 28th June 2019** and will be opened immediately thereafter at the Visitors' Lobby, Ground Floor of the Central Bank Head Office Building. Bidders or their authorized representatives are requested to be present at the opening of bids.
