INVITATION FOR BIDS

REPLACEMENT OF CENTRAL AIR CONDITIONING EQUIPMENT OF THE AUDITORIUM AT CENTRE FOR BANKING STUDIES, RAJAGIRIYA

1. The Director of Facilities Management of the Central Bank of Sri Lanka (CBSL) invites sealed bids till **1430 hrs. on 11th August 2020** from experienced contractors for the above works.
2. The works consist of dismantling and removal of the existing central air conditioning equipment and supply, installation and maintenance of a new water-cooled package type air conditioning system at the Auditorium of Centre for Banking Studies, No. 58, Sri Jayawardenepura Mawatha, Rajagiriya as specified in the Bidding Document.
3. In order to be eligible to bid, the bidder shall be a firm/company registered in Sri Lanka having experience at least during the last five (05) years ending 31st December 2019 in supply, installation and maintenance of central air conditioning equipment in Sri Lanka. In order to qualify for the award: (a) The bidder shall have satisfactorily completed at least three (03) central air conditioning installations during the last five (05) years ending 31st December 2019 with the contract value exceeding Rs. 5 million in each case; (b) The bidder shall be an authorized agent for supply, installation and maintenance of the proposed make of air conditioning equipment in Sri Lanka; and (c) the proposed make of air conditioning equipment shall have been in satisfactory service in Sri Lanka at least during the last three (03) years ending 31st December 2019.
4. Bidding Documents will be issued at the Mail Room, Central Bank Head Office Building, No. 30, Janadhipathi Mawatha, Colombo 1 from 0900 hrs. up to 1500 hrs. from **22nd July 2020 to 10th August 2020** during Bank working days upon receipt of a written request on a business letterhead and a non-refundable tender fee of Rs. 1,000/- per set in cash.
5. A pre-bid meeting will be convened at **1500 hrs on 31st July 2020** at the Centre for Banking Studies, Rajagiriya.
6. The time period for completion of whole of the works shall be 150 calendar days.
7. Bid shall be accompanied by a Bid Security of Rs. 75,000.00 valid for 90 calendar days obtained from a licensed commercial bank operating in Sri Lanka.
8. Duly filled bids secured in a sealed envelope should be sent by registered post to reach the Director of Facilities Management, Central Bank of Sri Lanka, No.30 Janadhipathi Mawatha, Colombo 1 or be lodged in the Tender Box placed at the Mail Room, Ground Floor, Central Bank Head Office Building by **1430 hrs on 11th August 2020**. 'Tender for Replacement of Central Air Conditioning Equipment at CBS' should be clearly labeled on the envelope.

9. Bids will be closed at **1430 hrs** on **11th August 2020** and will be opened immediately thereafter at the Ground Floor of the Central Bank Head Office Building. Bidders or their authorized representatives are requested to be present at the opening of bids.
10. The Central Bank of Sri Lanka reserves the right to accept any bid or reject any or all bids received and is not bound to accept the lowest bid
